Audit	<p>The Committee will advise the Board of Governors on the adequacy and effectiveness of the College’s systems of internal control and its arrangements for risk management, control and governance processes, and securing economy, efficiency and effectiveness. The Audit Committee shall ensure that the internal control systems and processes, including audit activities of the Board of Governors (and any subsidiaries) are monitored actively, independently and objectively.</p>
Remuneration	<p>The Remuneration Committee shall review the policy on the pay and conditions of service for the Principal and the holders of designated senior posts and make recommendations to the Board of Governors accordingly. Ensure that the Principal and holders of Senior Posts (as designated by the Board of Governors) are fairly rewarded for their individual contributions to the College’s overall performance. Demonstrate to the public that the pay of holders of senior posts is reviewed by a Committee which has no personal interest in the outcome of its recommendations and which gives due regard to the interests of the public and of the financial health of the college.</p>
Search & Governance	<p>The Search & Governance Committee shall advise the Board of Governors on the appointment of members of the Board (other than as a parent, staff or student governor) and such other matters relating to membership, appointments or governance as the Board of Governors may remit to the Committee.</p>
